# Documents Central State Historical Archives in Lviv as a Channel of Social Communication



The paper analyzes the archival documents of the Central State Historical Archives in Lviv as a channel of social communication. What is important for the analysis and study of military affairs, the medieval city of Lviv in the second half of the XIV-XVIII centuries. The paper presents a computerization of archives, which plays an important role in the archive as a structure of social communication, which will establish new facts in the history of the city.

#### I. Introduction

Social and communicative activity is the main condition for an existence and development of society. The most important channel of a social communication is a documentary communication, that is a processes and means of sharing information in the community through documents. It provides social information movement in time and environment by creating, storing and distributing documents.



Consider the archives as one of the basic structures of social communication. A rchive is an unique social and communication structure that helps society to ensure the continuity of generations.

Archive i s a s ocial and communication s tructure of social communication subsystem, an org anization dedicated to the collection, an alysis, study, us e and distribution i n ti me and s pace the s ocially significant documentary information found in archival documents to produce new knowledge.

Research on i ssues of functioning a n arc hive as a research center f or s ocial communication and s ocial communication pat terns ca n be f ound in t he works o f known researchers as G. B oriak [1], L. Dubrovin [2], S Kuleshov [3, 4].

### II. Page Setup

The larg est an d m ost complete array of sources is documents of Lviv ci ty council of t he period of t he second h alf of t he XIV - X VIII cen turies. Today, th is group of sources is well preserved and located in the Central State His torical A rchive in Lviv, which is a separate stock of number 52 "Magistrate of the city". This fund includes t wo des criptions and 2315 cas es. These materials cover the period b etween t he second h alf of XIV -XIX centuries.

In d ocuments r elating to military af fairs in U kraine (among them t here are decre es, ordin ances, res olutions, lustrations, a udit, d escriptions, la wsuits an d d ecisions called quits, etc.).

Actually, most of t he d ocuments r elating to military affairs in Uk raine in the second half of t he XIV - XVIII centuries are concerned with activities of the city council. Military a nd d efence a ffairs o f th e cit y co ncern resolutions, especially the city council ones. An example of t his t ype o f docum ent i s a res olution of t he extraordinary s ession of t he Lv iv ci ty coun cil of 1779 concerning a repair of buildings and use prisoners in these works [5].

Especially informative type of sources from which we can res earch t he cit y fortification a nd s upplying t he arsenals with ar ms an d ammunition i sr evisions, lustrations and descriptions of the city. At the initiative of local an d r oyal a uthorities the au dits an d l ustrations of f city fortifications and arsenals were conducted. Results of these in spections were deposited in acts of r evision, the lists o f a mmunition a nd o ther d ocuments o nt he availability, r etention, and s upervision of weapons a nd ammunition of cit y ars enals bet ween 1496- 1777. Nowadays these documents are in three cases (Ne 42-44) of the first description of the 52nd fund [6]. This is one of the most i nformative t ypes of d ocuments r elated to the development of military affair in Lviv.

Similar in con tent a nd s tructure th ere are acts of lustration of ci ty fortification (1648) [7]. To au dit t he Lviv magistrate, two shopkeeper were appointed and the city was conventionally divided into two sectors, where lustrations were h eld. De spite th eir n ame, th ese documents do not mention about the situation of the city walls or o ther L viv f ortifications, b ut j ust p rovide th e information on t he s tate of weapons a nd prov isions supplying of citizens liable for call-up for the case of the city siege, revealing their level of fighting capacity.

Information ab out Lviv strengthening and fortification is contained in the inventories of the se cond half of the XVIIIth cen tury. I n partic ular, there are preserved descriptions of 1774-1778, as well as a f ragment of the inventory of 1798 [8].

Another type of documents is registers of the costs for building and repairing fortifications. The collection of the Central State Archive in Lviv, in particular, preserves a register of costs for repairing Lviv Arsenal in 1632 [9].

## III. Page Setup

But an access to information resources of the archive is restricted in ter ms of consumers and room. Therefore, there is a need for their integration into a new information environment with its whole documentary volume. The digitization of ar chival r ecords will e nable the quick processing of huge in formation d atabases, will provide them with n ew qualitative p roperties, they'll b ecome active as they will be available to the wide a udience by means of computer s ystems and n etworks. The rapid development of in formation tech nologies, n etworks, communications and open access to information could not but affected the social and public relationships.

In the er a of globalization and in formatization of archives in our country, processes of electronic communications in archivals ector become of great importance, aff ecting the processes of functioning archives in today's social communication environment.

Informatization of arch ives in Uk raine and the development of information and communication technologies contributed to the rapid accumulation of documentary resources on electron ic digitals torage devices. In our country, the process of storing and systematic us e of electron ic heritage in modern social communication environment is governed by legal documents such as the Law of Ukraine "On Electron ic Documents and Electron ic Document Circulation "[10]"On electronic digital signature" [11] Order of the State Committee U kraine "Procedure f or storing electronic documents in archival institutions "[12] Law of Ukraine "On main principles of the Information Society in Ukraine in 2007-2015 years" [13].

### Conclusion

Utilization of documents of Lviv city council fund, as well as so me of p articular a cts of Lv iv city j udgement books (the Central State Historical Archive in Lviv) into the s cientific use will give the opportunity to dis cover new facts in the history of the city as a defence centre and to determine tr ends in th e p rocess of development of urban fortifications.

Thus, informatization of archives plays outstanding role in the act ivities of the arch ive as a structure of s ocial communication. Information processes of arch ive as a social communication structure will enable the Ukraine to move forward to a single g lobal information and communication environment more intensively.
